Definitions	
Affiliates	Companies are related by common ownership and control. They can be financial and nonfinancial companies.
	<ul> <li>We may share information with our affiliates for our everyday business purposes, including information about your transactions and experiences.</li> </ul>
Nonaffiliates	Companies not related by common ownership and control. They can be financial or nonfinancial companies.
	<ul> <li>We do not share with nonaffiliates so that they can market to you.</li> </ul>
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
	<ul> <li>We do not jointly market.</li> </ul>
